#### **INFRASTRUCTURE**

- The Airport Water Main Expansion Project broke ground in September. This is the first of 4 phases that will bring a 16" water main to the Airport, providing additional fire protection as well as opening new areas for future development.
- Rapid City's National Flood Insurance Program / Community Rating System Verification Report has improved from a Class 8 to Class 7 rating in Zone A. Thanks to the improved rating, homeowners may be eligible for a discount on their flood insurance premiums.
- Rapid City Regional Airport celebrated the completion of the Airport Expansion Project. After 23 years nearly every square foot of the airport's interior was updated. The new facility serves as a gateway to our area and now runs more efficiently than ever. The features of the project include a rooftop patio, expanded security, and a separate wing to house the rental car offices.

#### **PARTNERSHIPS**

- Memorial Park Promenade & Botanical Gardens will connect the Civic Center and Downtown areas by providing a space for walking, biking, picnicking, and social gathering in Memorial Park. Destination Rapid City is contributing the funds for the design & construction of this project.
- The City is partnering with the 24/7 **Program & Pennington County** Sheriff's Office to provide service to the community at an office space located at 108 E. Main Street.
- Partnered with Western Dakota Technical Institute (WDTI) for the Construction and Operation of a Fire Station and Training Center shared between City and Rapid City Area
- The Rapid City Public Library will be expanding an East Branch at the WDTI Campus. A joint partnership between the City, School, and County. One of the first such partnerships in the country.

#### **ACTIONS TAKEN**

- Chapel Valley has received national recognition for becoming the first Rapid City Firewise neighborhood for their efforts to reduce risk of urban wildfire.
- In 2012 the Fire Department has taken a proactive approach to the prevention of wild fire by completing & committing to over 80 fuel reduction projects that to date total 85+ acres inside City limits thru the Survivable Space Initiative. We have awarded a total of \$88k dollars for these projects thru the state 50/50 cost share grant, and in addition to that, the City has awarded over \$29k to assist home owner's projects thru their own hazardous fuel removal program. - The Mountain Pine Beetle Suppression Plan was reauthorized to assist home owners with the removal cost of infested trees with a YTD processed reimbursement total of \$156k with \$194k of remaining funds available.
- City Council unanimously approved Resolution No. 2011-114 as a permanent extension of the Disability Consideration Policy. Simply put, people who have a severe disability **and** who are qualified for the position will receive an interview.

## **GROWTH & ECONOMIC DEVELOPMENT**

- The City celebrated the opening of Anamosa Street connecting E. North Street & Lacrosse.
- Our first Industrial permits have been issued since 2008; two permits issued totaling nearly \$4.2m. More expected soon.
- The RCPD Street Crimes Unit has been expanded to residential areas in North Rapid City with the addition of four new officers. Since the introduction of the Street Crimes Unit in April 2010, Rapid City's central sector has seen a 10% reduction in calls for service.
- The concept of a Foreign Trade Zone is being explored to help local business with importing & exporting and to encourage manufacturing and industrial activity.

## INCREASED ACCESS TO YOUR CITY GOVERNMENT

- Established Ordinance No. 5854 requiring the City Finance Officer to report to the City Council yearly on the City's debt, including a general statement on the financial condition of the City. This is a companion ordinance to Ordinance No. 5761 which was passed last year to require periodic reporting of City cash & revenue balances.
- Media notices are sent out for all construction bid openings in an effort to increase access to City Government.

### FISCAL RESPONSIBILITY

- City Council unanimously accepted a \$375k settlement and confession of judgment from Fish Garbage Service in favor of the City. Fish has admitted to defrauding the taxpayers. Checks & balances are in place to prevent a future
- The City completed an internal rate study which resulted in an 8% decrease in the garbage collection rates saving ratepayers an estimated \$315k a year. The rate decrease affects 18.839 accounts and became effective October 1.
- Higher sales tax revenue and expiring Property Tax Increment Financing districts (TIFs) allowed us to balance the 2013 budget and provide for our growing city's needs without increasing property taxes or dipping into reserves. Overall, the budget was reduced by 1/2 percent, from \$138.5m in 2012 to \$137.8m in 2013.
